Country Malt sells to commercially licensed breweries, commercially licensed distilleries, or home brew shops. Unfortunately we cannot sell to homebrewers.

If you are a brewery or distillery, we will need a copy of your Federal TTB\* License (Brewers Notice or Distilled Spirits Plant Permit). Please fax or scan that along with your completed Customer Profile/Credit Application and optional Credit Card Authorization to us one week ahead of your initial order.

If you are a home brew shop, we will require a copy of your Business License, and a copy of your Reseller's Permit. Also please be aware that special rules apply, and our vetting process may take up to a week for home brew shops.

You are welcome to apply for credit terms with the included Credit Application. Otherwise, you will pre-pay by credit card or business check. For credit card purchases, please fill out the Credit Card Authorization form (page 3) and return with owner signature(s).

If you pay by check, please **fax your check** to our Credit Department at **360-905-3329**. Checks require 3 business days lead time per order, as we must wait for the check to clear the bank before we can release your order.

As regards orders & deliveries: We have three western warehouses, in Vancouver, WA, Hayward, CA and Denver, CO. Your orders will normally ship from the warehouse closest to you, although spot hops may be drop-shipped. You may also Will Call your orders at your nearest warehouse.
